



CORRIGENDUM 1 TO THE GUIDELINES FOR GRANT APPLICANTS

Call Reference: **EuropeAid/186089/DD/ACT/TZ**

“Strengthening Civil Society for Risk Mitigation and Dialogue in Support of EU-Tanzania Economic Cooperation”

This Call for Proposal was originally published on 13 March 2026. However, we understand that there were technical issues with the EU’s Funding and Tenders portal. The Contracting Authority has therefore decided to extend the period for submission and all other dates as detailed below. A new version of the “Guidelines to Grant Applicants” incorporating these changes (and shown in track changes) is attached in annex 1 to this corrigendum.

The guidelines for applicants are modified as follows:

1) **Cover page:** Deadline for submission of concept notes:

Instead of: “**27/04/2026** at 12:00 (Brussels date and time)”

Read: “**07/05/2026** at 12:00 (Brussels date and time)”

2) **Page 2: Information session**

Instead of: “**26 March 2026** at 11:00 hrs (local date and time)”

Read: “**13 April 2026** at 11:00 hrs (local date and time)”

and

Instead of: “please send an email by **24 March 2026**”

Read: “please send an email by **9 April 2026**”

3) **Section 2.2.3. Deadline for submission of concept notes**

Instead of: “The deadline for the submission of concept notes is **27/04/2026** at 12:00 (Brussels date and time).”

Read: “The deadline for the submission of concept notes is **07/05/2026** at 12:00 (Brussels date and time).”

4) **Section 2.2.4. Further information about concept notes**

Instead of: “24 March 2025 at 11:00 hrs (local date and time)”

Read: “13 April 2026 at 11:00 hrs (local date and time)”

5) **Section 2.7. Indicative timetable**

The timetable is replaced with that the table below; all other text remains unchanged
